TAB 2-IH-01- Garo Charles Avetian, D.O, case# 2017-19816 (ALP) *PCP: Andriole/Jackson*

Respondent was not present. Respondent was not represented by counsel.

Ms. Jackson was recused due to participation on the probable cause panel.

Matt Witters represented the Department and presented the case to the Board. Allegations of the Administrative Complaint: violation of Section 459.015(1)(b), Florida Statutes (2017), by having a license or the authority to practice osteopathic medicine revoked, suspended, or otherwise acted against, including the denial of licensure, by the licensing authority of any jurisdiction, including its agencies or subdivisions. On or about November 16, 2018, Respondent was served via certified mail. An election of rights was timely received requesting an informal hearing.

Motion: by Dr. Hayden, seconded by, Dr. Bellingar, that the Respondent was properly served and is properly before the board as an informal hearing. Motion carried.

Motion: by Dr. Schwemmer, seconded by, Dr. Hayden, to accept the Investigative Report in evidence for the purposes of imposing a penalty.

Motion carried.

Motion: by Dr. Hayden, seconded by, Dr. Mendez, to adopt the findings of fact as set forth in the Administrative Complaint. Motion carried.

Motion: by Dr. Hayden, seconded by, Dr. Bellingar, to adopt the conclusions of law as set forth in the Administrative Complaint. Motion carried.

PSU attorney read the proposed disciplinary guidelines.

Motion: by Dr. Bellingar, seconded by, Dr. Hayden, to impose the following discipline: Reprimand; one-month suspension followed by one-year probation or probation until such time as Respondent can demonstrate his Pennsylvania license is free and unencumbered, during probation the Respondent is restricted from prescribing medications to patients via remote prescribing in Florida, including the following:

(1) Remote Prescribing as defined herein, which would include, but is not limited to, remote prescribing via telephone, video-link or online.

(2) Remote Prescribing is defined as prescribing, dispensing or furnishing a prescription medication or a prescription-only device to a person without conducting a physical examination of that person or without having a previously established physician-patient relationship. A proper physician-patient relationship means that before the issuance of a prescription, a physician performs a history and in-person physical examination of the patient adequate to establish a diagnosis and to identify underlying conditions or contraindications to the treatment recommended.

Motion: by Dr. Hayden, seconded by, Dr. Bellingar, to impose costs in the amount of two hundred nineteen dollars and seventy-one cents (\$219.71) to be paid within one year of the Final Order in this matter.

Ms. Janson was recused due to participation on the probable cause panel.

Allison Dudley represented the Department and presented the case to the Board. Allegations of the Administrative Complaint: violation of Section 459.015(1)(b), Florida Statutes (2016), by having a license or the authority to practice osteopathic medicine revoked, suspended, or otherwise acted against, including the denial of licensure, by the licensing authority of any jurisdiction, including its agencies or subdivisions.

The terms of the settlement agreement are: Appearance, letter of concern; fine of two thousand dollars (\$2,000.00) to be paid within thirty (30) days of the filing of the Final Order in this matter, any change in terms must be approved in advance by the Probation Committee of the board; reimbursement of costs for the investigation and prosecution of this case are capped at the amount of one thousand two hundred eighty-eight dollars and sixty-one (\$1288.61) cents, actual costs are four hundred thirty dollars and thirty-three (\$430.33) cents to be paid within thirty (30) days of the filing of the Final Order in this matter; Respondent's license will have a practice restriction consistent with the Alabama discipline. There was a verbal agreement to remove the term to allow the Respondent ninety days to come into compliance.

An oral agreement was reached to remove the provision referencing Probation Committee in both the fine and cost requirements of the agreement.

The terms of the settlement agreement are: Appearance, letter of concern; reimbursement of costs for the investigation and prosecution of this case in the amount of one thousand six hundred forty-five dollars and seventy-six (\$1645.76) cents to be paid within thirty (30) days of the filing of the Final Order in this matter; There was a verbal agreement to remove the reference to Probation Committee on pages three and four of the agreement.

Ms. Monroe and Ms. McNulty will work together with Dr. Hayden on application language to better clarify the NICA fee and dispensing applications. Proposed language is to be brought to the board meeting in August.

Discussion ensued regarding joint committees and committee members. After discussion, the office surgery committee members will be Dr. Rose, Dr. Schwemmer, and Dr. Hayden. The telemedicine committee will be Dr. Rose, Dr. Schwemmer, and Dr. Hayden will be the third member for both committees.
